- ☐ **1. Menu** — Confirm each product under Alabama cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Alabama home-kitchen disclaimer (see live label one-pager)

HANDWASHING	No specific state cottage food handwashing mandate beyond food safety course training.

Inspection & permitting

INSPECTION REQUIRED	No — No routine inspection; county health department approves initial application.
HOME OCCUPATION PERMIT	Yes — Russell County Health Department approval is required before selling. Operators must complete a state-approved food safety course and submit proof of training, a sample label, and product list to the county health department. Fees vary by county.

Relevant county code

Russell County Health Department procedures (county health department approval required); no specific cottage food county ordinance identified.

RESEARCH NOTES

Alabama requires county health department approval — Russell County Health Dept. should be contacted directly. Phenix City is on the Georgia border near Columbus, GA. Acidified foods require pH testing. Freeze-dried foods require water-activity testing.

State context — Alabama cottage food law

Russell County's rules sit on top of Alabama's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.
