- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

RESEARCH NOTES

Washington County AR follows the Arkansas Food Freedom Act (A.C.A. §20-57-201), one of the most permissive nationally. The law expressly preempts local restriction. Fayetteville is home to University of Arkansas. No county-specific cottage food rules found or needed due to state preemption. Interstate sales allowed. Confidence medium — state law confirmed but no specific Washington County .gov cottage food source retrieved.

State context — Arkansas cottage food law

Washington County's rules sit on top of Arkansas's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.
