- ☐ **1. Menu** — Confirm each product under Florida cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Florida home-kitchen disclaimer (see live label one-pager)

Small agricultural/sugar cane county (pop. ~42,000) with county seat LaBelle. Local business tax receipt and possible zoning approval likely required. LOCAL BUSINESS LICENSE Likely; Hendry County local business tax receipt; contact Hendry County Tax Collector

ON-SITE CUSTOMER PICKUP True

ON-SITE SIGNAGE Must comply with Hendry County signage ordinances

DELIVERY / PICKUP RULES Direct-to-consumer; online/mail-order allowed; shipping within and across state lines via USPS or commercial carrier; no wholesale/consignment; max \$250,000 annual gross sales

MAX EMPLOYEES IN HOME No state limit; local home occupation rules may apply

RESEARCH NOTES

No Hendry County-specific cottage food or home occupation ordinance surfaced in search. Agricultural/sugar cane county in southwest Florida. State baseline (Fla. Stat. §500.80) governs; county cannot restrict cottage food production.

State context — Florida cottage food law

Hendry County's rules sit on top of Florida's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

Limited (see notes) — Florida prohibits wholesale sales but allows online, mail-order, and in-person sales including delivery to consumers; state law preempts local restrictions on cottage food operations.
