- ☐ **1. Menu** — Confirm each product under Florida cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Florida home-kitchen disclaimer (see live label one-pager)

INSPECTION REQUIRED	Upon-complaint — Complaint only. Polk County Health Department has no additional inspection authority.

RESEARCH NOTES

Polk County follows Florida state baseline. Strong preemption means no local restriction on cottage food operations. No Polk County-specific cottage food ordinance found beyond state law.

State context — Florida cottage food law

Polk County's rules sit on top of Florida's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

Limited (see notes) — Florida prohibits wholesale sales but allows online, mail-order, and in-person sales including delivery to consumers; state law preempts local restrictions on cottage food operations.
