- ☐ **1. Menu** — Confirm each product under Idaho cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Idaho home-kitchen disclaimer (see live label one-pager)

HOME KITCHEN ALLOWED?

Yes (Must be non-TCS (non-time/temperature control for safety) foods only. All sales must be direct to consumer within Idaho. No sales to retailers, distributors, or brokers. No sales outside Idaho. Acidified foods prohibited under cottage food framework.)

PETS ALLOWED?

Not required by state law; minimizing pet contamination risk is recommended but not mandated.

HOME OCCUPATION PERMIT?

Conditional (Rexburg city code or Madison County may require a business license and/or home occupation permit depending on location. No state food permit required. Cottage food operations must have a sales tax permit. Farmers markets and other venues may require their own approvals.)

Home kitchen rules

HOME KITCHEN ALLOWED	Yes — Must be non-TCS (non-time/temperature control for safety) foods only. All sales must be direct to consumer within Idaho. No sales to retailers, distributors, or brokers. No sales outside Idaho. Acidified foods prohibited under cottage food framework.
SEPARATE DEDICATED KITCHEN	No
PET RESTRICTIONS	Not required by state law; minimizing pet contamination risk is recommended but not mandated.
WATER SUPPLY	Not required by state law; well water testing recommended but not mandated.
HANDWASHING	Standard food safety practices recommended; not explicitly required by state cottage food rules.
FOOD STORAGE	Standard residential storage; products must remain non-potentially hazardous.

Inspection & permitting

INSPECTION REQUIRED	No — No license or inspection required. Completing a Cottage Foods Risk Assessment Form (signed by local health district Environmental Health Specialist) is strongly recommended but not required. Public Health District 5 (covers Madison County) may be consulted.
HOME OCCUPATION PERMIT	Conditional — Rexburg city code or Madison County may require a business license and/or home occupation permit depending on location. No state food permit required. Cottage food operations must have a sales tax permit. Farmers markets and other venues may require their own approvals.

MAX EMPLOYEES IN HOME	Not specified in state cottage food law.

RESEARCH NOTES

Idaho's cottage food framework requires no license or inspection for direct-to-consumer sales of non-TCS foods. Madison County is served by Public Health District 5 (South Central). City of Rexburg and/or Madison County may require a business license and/or home occupation permit for home-based businesses. A sales tax permit is required. Completing the Cottage Foods Risk Assessment Form with Public Health District 5 signature is strongly recommended. No county-specific cottage food ordinances found.

State context — Idaho cottage food law

Madison County's rules sit on top of Idaho's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.
