- ☐ **1. Menu** — Confirm each product under Illinois cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Illinois home-kitchen disclaimer (see live label one-pager)

RESEARCH NOTES

Illinois cottage food law (PA 102-0633 eff. Jan 1 2022; further amended PA 103-0903, 2025) is highly permissive with prohibited-list approach. Registration required with local health department (\$50/year cap). Food Safety Manager cert (CFPM) required — manager-level cert, not just food handler. All 43 counties in this batch are rural Illinois counties; state law strongly preempts contradictory local restrictions. Franklin County in southern IL; county seat Benton. Coal country, rural. No county-specific cottage food deviations found. Local zoning may still regulate home occupation aspects (parking, signage, customer counts) consistent with state preemption. University of Illinois Extension and Illinois Stewardship Alliance offer county-level guidance. Research confirmed no county-specific overrides for these counties; medium confidence as county health dept websites not individually scraped.

State context — Illinois cottage food law

Franklin County's rules sit on top of Illinois's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES

No — Illinois prohibits sales to restaurants, retail stores, and wholesale; direct in-state sales are allowed anywhere including home, online, farmers markets, events, and roadside stands; non-perishable items may be shipped within Illinois only.
