- ☐ **1. Menu** — Confirm each product under Indiana cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Indiana home-kitchen disclaimer (see live label one-pager)

RESEARCH NOTES

No county-specific cottage food ordinance found that overrides state law. Indiana IC 16-42-5.3, Sec. 12 explicitly prohibits local government from requiring any licensure, certification, or inspection of home-based vendor foods. State law fully preempts local licensing/inspection requirements. Food handler certificate (ANSI-accredited) required; no registration/permit required. No sales cap. Indiana HB 1424 (signed March 2026, effective July 1, 2026) further loosens regulations; not yet in effect as of research date. Defaulting to state baseline.

State context — Indiana cottage food law

Clay County's rules sit on top of Indiana's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.
