- ☐ **1. Menu** — Confirm each product under Iowa cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Iowa home-kitchen disclaimer (see live label one-pager)

Wright County is a rural north-central Iowa county (pop. ~12,600). No specific county zoning ordinance text was located for Wright County in research. Iowa cottage food law (§137F.1/§137F.20) governs food safety; no license or inspection required; direct sales only; non-TCS foods. County zoning home occupation rules are assumed to follow standard Iowa rural county patterns (accessory use, resident-operated, no exterior display). State context — Iowa cottage food law

Wright County's rules sit on top of Iowa's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.
