- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Mississippi home-kitchen disclaimer (see live label one-pager)

No registration required.

No Lee County-specific cottage food code identified. Miss. Code Ann. §75-29-951 governs.

RESEARCH NOTES

Lee County (Tupelo - birthplace of Elvis Presley) follows Mississippi cottage food law. Note: the input had scrambled field data for this county (the county_govt_url, county_health_url fields appeared to contain state dept name and tier text respectively, which are data entry errors). The MSDH state URL in input was also incorrect (public water supply page); the correct MSDH cottage food page is msdh.ms.gov/msdhsite/_static/30,0,77,620.html per research. \$35,000 annual cap confirmed. No county-specific overrides found. Confidence is medium: state law confirmed from Justia; county-level rules not verified.

State context — Mississippi cottage food law

Lee County's rules sit on top of Mississippi's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES No — Mississippi prohibits Internet sales, mail order, wholesale, and retail establishment sales. Cottage food products may only be sold through in-person direct-to-consumer channels including events, farmers markets, home sales, and roadside stands. Advertising on the Internet including social media is permitted even though sales through those channels are not.
