- ☐ **1. Menu** — Confirm each product under Mississippi cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Mississippi home-kitchen disclaimer (see live label one-pager)

HANDWASHING	Standard sanitation practices; not specifically required.
FOOD STORAGE	Products must be non-potentially hazardous and not require refrigeration.

INSPECTION REQUIRED	Upon-complaint — No routine inspection. MSDH may inspect upon complaint or suspected foodborne illness.
HOME OCCUPATION PERMIT	Conditional — No specific Oktibbeha County cottage food or home occupation rules found. City of Starkville may have business license requirements. Recommend verifying with Oktibbeha County and City of Starkville planning departments.

RESEARCH NOTES

Mississippi's cottage food law is relatively restrictive: \$35,000 cap, direct in-person sales only, no internet/mail order. Oktibbeha County includes Mississippi State University. State context — Mississippi cottage food law

Oktibbeha County's rules sit on top of Mississippi's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES

No — Mississippi prohibits Internet sales, mail order, wholesale, and retail establishment sales. Cottage food products may only be sold through in-person direct-to-consumer channels including events, farmers markets, home sales, and roadside stands. Advertising on the Internet including social media is permitted even though sales through those channels are not.
