- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

HOME KITCHEN ALLOWED?

Yes (Missouri state law (§196.298) permits home kitchen production of nonperishable baked goods, canned jams/jellies, and dried herbs with a \$50,000 annual gross income cap and direct-to-consumer sales only. Internet sales are prohibited under the statute. State law expressly prohibits local health departments from regulating cottage food production (§196.298(3)(1)). No county-specific home occupation permit ordinance was identified for unincorporated Nodaway County.)

No — Missouri law expressly bars local health departments from regulating cottage food production (§196.298(3)(1)). No routine inspections. State may investigate foodborne illness complaints.

Unknown — No county-level home occupation permit ordinance identified for unincorporated Nodaway County through available sources. Operators in the City of Maryville should check Maryville municipal code separately.

RESEARCH NOTES

State baseline applied. No county-specific home occupation zoning ordinance found for unincorporated Nodaway County. Missouri §196.298 expressly bars local health department regulation of cottage food production. The 2022 HB 1697 amendment removed the sales cap and added online in-state sales per MDHSS guidance; however the statute text on revisor.mo.gov still shows the \$50,000 cap, so medium confidence on current cap status. City of Maryville has its own regulations not researched here.

State context — Missouri cottage food law

Nodaway County's rules sit on top of Missouri's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES

No — Under §196.298, sales must be directly to consumers from the producer's home. Events, farmers markets, restaurants, retail stores, and roadside stands are not permitted under this law. Internet/online sales are allowed but only if both the producer and buyer are located in Missouri. Local health departments are explicitly prohibited from regulating the production of food at cottage food operations. A separate Missouri statute (individual stands law) allows sales at events and roadside stands in counties that have adopted it, permitting most other nonperishable foods.
