- ☐ **1. Menu** — Confirm each product under Nevada cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Nevada home-kitchen disclaimer (see live label one-pager)

RESEARCH NOTES

Churchill County cottage food operations are registered through and regulated by the Central Nevada Health District (CNHD), which covers Churchill, City of Fallon, Pershing, Mineral, and Eureka counties. CNHD registration form (Dec 2023) confirms \$35,000 annual cap, direct-to-consumer only, no internet/phone sales. A state NV business license is required; Churchill County may have its own business license requirement. The pre-2025 NRS 446.866 framework is reflected here; AB352 (2025) raised the cap to \$100,000 and may expand sales channels but the new codified text was not directly verified. Medium confidence due to 2025 statutory changes in transition.

State context — Nevada cottage food law

Churchill County's rules sit on top of Nevada's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES	
No — Under the pre-2025 law (NRS 446.866), sales must be in-person transactions only — no internet or phone sales. Products may not be sold to wholesalers, brokers, distributors, or retail establishments for resale. AB352 (2025) amends this to allow phone and internet transactions with delivery via mail or food delivery service, but product relinquishment must still occur in Nevada. Local rules vary significantly: Clark County (Las Vegas), Washoe County, Carson City, and Douglas County have separate health authority requirements.
