- ☐ **1. Menu** — Confirm each product under Ohio cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Ohio home-kitchen disclaimer (see live label one-pager)

No specific statutory handwashing mandate beyond good manufacturing practices.

Non-potentially hazardous, shelf-stable foods only per OAC 901:3-20-04 approved product list.

Inspection & permitting

INSPECTION REQUIRED

No — ODA has sampling authority; no routine inspection required.

Harrison County is a small rural county in eastern Ohio (oil/gas region). No county-specific cottage food or home occupation ordinance found. Defaulted to Ohio state baseline at medium confidence.

State context — Ohio cottage food law

Harrison County's rules sit on top of Ohio's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

Yes — Labeled cottage food products may be sold to or used by retail food establishments and food service operations licensed under Ohio Revised Code Chapter 3717. This enables indirect/wholesale sales within Ohio. Products may not be sold outside the state of Ohio.
