- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

Labeling must include producer name/phone, physical address, product description, ingredients, allergens, and the statement 'This product was produced in a private residence that is exempt from government licensing and inspection.' Local ordinances, Tax Commission, and FDA rules may also apply.)

No county-specific cottage food ordinance identified. State law (2 O.S. §§5-4.1 through 5-4.6) governs. Local zoning may apply in unincorporated areas.

RESEARCH NOTES

Beaver County is in the Oklahoma Panhandle (No Man's Land area), one of the most sparsely populated counties in the state. Oklahoma's Homemade Food Freedom Act is one of the most permissive in the nation: broad food categories, \$75,000 annual cap, no license, indirect sales allowed. No county-specific ordinance found. Defaulted to Oklahoma state baseline at medium confidence.

State context — Oklahoma cottage food law

Beaver County's rules sit on top of Oklahoma's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES

Limited (see notes) — Sales are permitted on site, by delivery, at farmers markets, through cooperatives, and through membership-based buying clubs. The Oklahoma Department of Agriculture, Food, and Forestry may promulgate rules to allow sales at other locations or by other means. County ordinances may regulate but may not conflict with or impede the Act. For TCS foods, the producer must complete an approved food safety training (e.g., ServSafe Food Handler Training, max 8 hours, available online) before selling.
