- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

Yes (Production must occur at producer's primary residence. Annual gross sales cap of \$75,000. Non-TCS foods: no license, inspection, or registration required. TCS foods: must complete approved food safety training (ServSafe or ODAFF-approved, ≤8 hours) before selling. Labeling required on all products (producer name/address, ingredients, allergens, net weight, 'Made in a Home Kitchen - Not Inspected by the Oklahoma Department of Agriculture, Food and Forestry or the Oklahoma State Department of Health'). Voluntary ODAFF registration available (\$15/year).)

Not specified in state law; standard sanitation practices apply

HOME OCCUPATION PERMIT?

No (Grant County is a rural county with no identified county-wide zoning ordinance for unincorporated areas. The City of Medford (county seat) may require a business license and home occupation permit for businesses within city limits. State law (§5-4.6) allows counties to adopt non-conflicting ordinances.)

Labeling required on all products (producer name/address, ingredients, allergens, net weight, 'Made in a Home Kitchen - Not Inspected by the Oklahoma Department of Agriculture, Food and Forestry or the Oklahoma State Department of Health'). Voluntary ODAFF registration available (\$15/year).

RESEARCH NOTES

Oklahoma Homemade Food Freedom Act (HB 1032, 2021) applies statewide. Grant County is a predominantly rural county. No county-level zoning ordinance or cottage food overlay identified for unincorporated areas. The City of Medford and any incorporated municipalities within the county have their own municipal zoning requirements that supersede county rules within city limits. State law expressly prohibits county ordinances from conflicting with or restricting the HFFA (2 O.S. §5-4.6). \ \$75,000 annual sales cap. TCS foods allowed with food safety training (ServSafe or equivalent).

State context — Oklahoma cottage food law

Grant County's rules sit on top of Oklahoma's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES

Limited (see notes) — Sales are permitted on site, by delivery, at farmers markets, through cooperatives, and through membership-based buying clubs. The Oklahoma Department of Agriculture, Food, and Forestry may promulgate rules to allow sales at other locations or by other means. County ordinances may regulate but may not conflict with or impede the Act. For TCS foods, the producer must complete an approved food safety training (e.g., ServSafe Food Handler Training, max 8 hours, available online) before selling.
