- ☐ **1. Menu** — Confirm each product under Pennsylvania cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Pennsylvania home-kitchen disclaimer (see live label one-pager)

PET RESTRICTIONS	Standard food safety GMP practices apply; inspection will assess kitchen cleanliness and sanitation.
WATER SUPPLY	Potable water required; well water testing may be required if not on public system per inspection.
HANDWASHING	Adequate handwashing facilities required and will be assessed at inspection.
FOOD STORAGE	Non-TCS shelf-stable products required. No refrigerated finished products. Acidified/fermented foods have specific pH/water activity testing requirements.

Inspection & permitting

INSPECTION REQUIRED	Yes — Initial on-site inspection required before registration issued. Subsequent routine inspections apply per PA LFE regulations. Submit application at least 60 days before operating.
HOME OCCUPATION PERMIT	Varies — Blair County and the city of Altoona may have local zoning home occupation requirements separate from state LFE registration. No specific Blair County home occupation permit details found. State LFE registration is the primary regulatory requirement.

State context — Pennsylvania cottage food law

Blair County's rules sit on top of Pennsylvania's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

INDIRECT SALES

Limited (see notes) — Registration includes sales direct from the production site including internet sales. However, a separate Retail Food Facility License may be required for sales at events or Farmers Markets. Businesses aiming to sell across state lines might also need FDA registration. The registration covers home-based operations in residential kitchens as well as residential-style kitchens in alternate locations such as churches, fire halls, or remodeled garages. Not available in Philadelphia County.
