- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

- ☐ Product name · producer name · address (or allowed alternative)

Fulton County falls within PA Region 5 (Martinsburg office: 403 E. Christiana St., Martinsburg PA 16662, 814-793-1849). No county-wide zoning; municipalities govern.

State context — Pennsylvania cottage food law

Fulton County's rules sit on top of Pennsylvania's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

Limited (see notes) — Registration includes sales direct from the production site including internet sales. However, a separate Retail Food Facility License may be required for sales at events or Farmers Markets. Businesses aiming to sell across state lines might also need FDA registration. The registration covers home-based operations in residential kitchens as well as residential-style kitchens in alternate locations such as churches, fire halls, or remodeled garages. Not available in Philadelphia County.
