- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

Relevant county code

No county zoning ordinance identified for unincorporated Refugio County. State law preempts local cottage food regulation.

RESEARCH NOTES

Refugio County is a small South Texas county on the Gulf Coast plain. Texas counties outside incorporated municipalities generally have no zoning authority. SB 541 (2025) explicitly bars local fees/permits. Defaulted to state baseline; no county-specific cottage food ordinance found.

State context — Texas cottage food law

Refugio County's rules sit on top of Texas's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

Limited (see notes) — Sales must be made directly to consumers or to a 'cottage food vendor' (a new category created by SB 541 in 2025 – a person with a contractual relationship who sells on behalf of the cottage food operation to consumers in-state). Cottage food products may not be sold as ingredients to a food service establishment. No retail grocery store or wholesale sales permitted under the pre-2025 framework; SB 541 (2025) adds the cottage food vendor intermediary option. Products must be delivered to consumer or vendor at point of sale or consumer-designated location.
