- ☐ **1. Menu** — Confirm each product under Washington cottage food rules (county cannot expand a state ban).
- ☐ **2. Pickup & zoning** — Home occupation and porch pickup cells above; HOA/lease may still block customer traffic.
- ☐ **3. Local tax / license** — Business license or sales tax certificate if your city/parish requires it (common even with no state food permit).
- ☐ **4. Training** — Food handler or state registration before market day.
- ☐ **5. Labels** — Disclaimer, allergens, ingredients, net quantity, producer info.
- ☐ **6. Call if unclear** — County health and planning for your exact address.

LABEL FIELDS TO INCLUDE

- ☐ Product name · producer name · address (or allowed alternative)
- ☐ Ingredients by weight · major allergens · net weight/quantity
- ☐ Washington home-kitchen disclaimer (see live label one-pager)

No THC ingredients. Only permittee or persons under direct supervision may handle cottage food products or be in the kitchen during processing.
SEPARATE DEDICATED KITCHEN	No
PET RESTRICTIONS	No persons other than permittee or directly supervised persons allowed in kitchen during processing.
WATER SUPPLY	Potable water required.
HANDWASHING	Food and beverage service worker's permit required under chapter 69.06 RCW.
FOOD STORAGE	Non-potentially-hazardous shelf-stable products must be stored appropriately.

Inspection & permitting

INSPECTION REQUIRED	Yes — Annual basic hygiene inspections required. Biennial permit with inspection (\$125 fee plus \$75 public health review + \$30 processing fee).
HOME OCCUPATION PERMIT	Yes — State-level biennial cottage food permit required from WSDA. Grays Harbor County public health administers local inspection component. No Grays Harbor County-specific additional cottage food ordinance found.

ON-SITE CUSTOMER PICKUP	Yes
ON-SITE SIGNAGE	Conditional
DELIVERY / PICKUP RULES	Direct sales to end consumers only within Washington. No internet, mail order, or out-of-state sales. No sales to restaurants or grocery stores.
MAX EMPLOYEES IN HOME	Only permittee or persons under direct supervision may handle cottage food or be in the kitchen during processing.

RCW §69.22.010-.040. No Grays Harbor County-specific code section found.

RESEARCH NOTES

Grays Harbor County follows Washington State cottage food law (RCW §69.22). Annual inspections required. No county-specific overrides found. Confidence: medium (state law verified, no county-specific ordinance confirmed).

State context — Washington cottage food law

Grays Harbor County's rules sit on top of Washington's state cottage food framework. The state law sets the floor — counties can add but cannot remove protections.

No — Cottage food products may only be sold directly to the consumer. Internet sales, mail order, and retail sale outside Washington state are explicitly prohibited. Products may not be repackaged, sold, or used as an ingredient by a food processing plant, or sold by a food service establishment.
