Where to file

State

Alabama registration: Yes. Routine kitchen inspection: No. Indirect sales to grocery stores, restaurants, or wholesale are not permitted; producers may use an agent for delivery but cannot sell through retailers.

Zoning / home occupation

Varies. No state requirement for home occupation permit for cottage food. Barbour County is rural with limited zoning. No county-level home occupation ordinance found. Check with Barbour County Commission for any local business license requirements.

Health

No. Cottage food operations are not food service establishments and not subject to routine health department inspection per §22-20-5.1(b). Complaints may trigger review.

Pickup / delivery

Direct to consumer only; in-person, phone, or online within Alabama. Delivery by producer or agent to consumers within state allowed.

If you rent a commissary kitchen

A commercial kitchen is a food establishment. Alabama cottage food is not a food-service permit. A commissary, restaurant, or shared kitchen is a food establishment permitted by the county health department. Ask that office for the food-facility application, not the cottage-food form.
