Where to file

State

Alabama registration: Yes. Routine kitchen inspection: No. Indirect sales to grocery stores, restaurants, or wholesale are not permitted; producers may use an agent for delivery but cannot sell through retailers.

Varies. No state requirement. Choctaw County is very rural with minimal local regulatory infrastructure. No county-level home occupation ordinance found.

If you rent a commissary kitchen

A commercial kitchen is a food establishment. Alabama cottage food is not a food-service permit. A commissary, restaurant, or shared kitchen is a food establishment permitted by the county health department. Ask that office for the food-facility application, not the cottage-food form.
