Where to file

State

Alabama registration: Yes. Routine kitchen inspection: No. Indirect sales to grocery stores, restaurants, or wholesale are not permitted; producers may use an agent for delivery but cannot sell through retailers.

Varies. No state requirement. Escambia County AL (not to be confused with Escambia County FL) is rural in south Alabama. No county-level home occupation ordinance found.

If you rent a commissary kitchen

A commercial kitchen is a food establishment. Alabama cottage food is not a food-service permit. A commissary, restaurant, or shared kitchen is a food establishment permitted by the county health department. Ask that office for the food-facility application, not the cottage-food form.
