Where to file

State

Arkansas registration: No. Routine kitchen inspection: No. Retail and wholesale sales are allowed so long as the product is sold to an informed end consumer who can see the product label; sales to businesses for ingredient use or gift resale are not permitted.

Zoning / home occupation

No. Arkansas Food Freedom Act (A.C.A. §20-57-201) expressly preempts all local government restrictions including permit requirements.

Health

No. Arkansas Food Freedom Act prohibits all local restrictions including inspections.

Business license

Pickup / delivery

Arkansas allows direct and indirect sales including online, retail/wholesale, and interstate sales. No channel restrictions.

If you rent a commissary kitchen

A commissary needs a food-service permit. Arkansas cottage food does not replace a food-service permit. Shared and commercial kitchens are permitted by the Arkansas Department of Health.
