Where to file

State

Arkansas registration: No. Routine kitchen inspection: No. Retail and wholesale sales are allowed so long as the product is sold to an informed end consumer who can see the product label; sales to businesses for ingredient use or gift resale are not permitted.

Zoning / home occupation

No. Arkansas Food Freedom Act expressly preempts both state and local government from restricting home food producers. No home occupation permit may be required.

Health

No. State law preempts local inspection requirements. No routine inspection.

Pickup / delivery

Almost unlimited: direct, indirect, retail, wholesale, online, in-state and interstate sales all permitted.

If you rent a commissary kitchen

A commissary needs a food-service permit. Arkansas cottage food does not replace a food-service permit. Shared and commercial kitchens are permitted by the Arkansas Department of Health.
