If you want a shop or a rented commercial kitchen, these rows do not apply.

HOW THIS PLACE WORKS

California cottage food is registered at the county. CDPH does not issue cottage-food permits. Class A registration and Class B permits are handled by the county (or city) environmental health department where you live. If this file only has a county homepage, call Environmental Health and ask for the cottage-food (CFO) page. Class A is registration. Class B is a permit.

Where to file

State

California registration: Yes. Routine kitchen inspection: No. Class B permit holders may sell indirectly through retail stores and restaurants statewide; Class A registrants are limited to direct sales only and may not sell through any retail or wholesale venue.

Zoning / home occupation

Yes. All CFOs in San Bernardino County must obtain planning/zoning approval before EHS registration. In incorporated cities: a Home Occupation Permit and business license from the city planning department. In unincorporated county areas: an Exemption Letter from San Bernardino County Code Enforcement Services. Requirements vary by jurisdiction.

Health

Conditional. Class A: no routine inspection; inspection only upon complaint. Class B: initial inspection before permit issuance; annual inspection thereafter.

Business license

Yes

Pickup / delivery

Direct/indirect sales within California only; state baseline applies. Up to 1 full-time equivalent employee (not family/household member) allowed.

If you rent a commissary kitchen

CDPH does not permit commissaries. Counties do. California cottage food (Class A/B) is county environmental health. A commissary, restaurant, or shared kitchen is a retail food facility under CalCode, also at county environmental health, on a different application than the CFO form.
