This is what it takes to sell from a home kitchen in Kiowa County. Confirm each step with Planning, Health, and the license office before you sell.

What you need

Kiowa County, Colorado. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Colorado registration: Yes. Routine kitchen inspection: Upon-complaint. Products cannot be resold; producers must sell directly to consumers but may designate a representative to sell on their behalf. Sales through restaurants or retail stores are not permitted, though the health department may allow direct sales at those locations on a case-by-case basis.

Zoning / home occupation

Possibly. Colorado cottage food law does not require a local permit. Kiowa County is a very rural southeastern plains county. Producers should verify with Kiowa County whether any home occupation permit is required.

Unlikely; very rural county with minimal business licensing; confirm with Kiowa County or Town of Eads

Pickup / delivery

Direct-to-consumer sales only; product must be sold in Colorado; cannot sell to restaurants or grocery stores

If you rent a commissary kitchen

Retail food licenses are local. Colorado cottage foods cannot be sold in a retail food establishment as an approved source. A commissary is a retail food establishment licensed by the local public health agency.
