What you need

Ouray County, Colorado. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Colorado registration: Yes. Routine kitchen inspection: Upon-complaint. Products cannot be resold; producers must sell directly to consumers but may designate a representative to sell on their behalf. Sales through restaurants or retail stores are not permitted, though the health department may allow direct sales at those locations on a case-by-case basis.

Zoning / home occupation

Likely; verify with Ouray County Planning. No county-specific home occupation code located for unincorporated Ouray County. Very small county (pop. ~5,000). City of Ouray has separate municipal zoning. Confirm with Ouray County Land Use.

Health

Upon-complaint only. CDPHE complaint-based inspection under C.R.S. §25-4-1614

Business license

Possibly; verify with Ouray County and Town of Ouray

Pickup / delivery

Direct-to-consumer only; no wholesale; may sell from residence, farmers markets, online (CO only)

If you rent a commissary kitchen

Retail food licenses are local. Colorado cottage foods cannot be sold in a retail food establishment as an approved source. A commissary is a retail food establishment licensed by the local public health agency.
