This is what it takes to sell from a home kitchen in San Juan County. Confirm each step with Planning, Health, and the license office before you sell.

What you need

San Juan County, Colorado. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Colorado registration: Yes. Routine kitchen inspection: Upon-complaint. Products cannot be resold; producers must sell directly to consumers but may designate a representative to sell on their behalf. Sales through restaurants or retail stores are not permitted, though the health department may allow direct sales at those locations on a case-by-case basis.

Zoning / home occupation

Likely; verify with San Juan County. No county-specific home occupation code located. San Juan County is the least populous county in Colorado (~700 residents). Town of Silverton is the only incorporated place. Confirm with San Juan County.

Upon-complaint only. CDPHE complaint-based inspection under C.R.S. §25-4-1614

Business license

Possibly; verify with San Juan County Clerk or Town of Silverton

Pickup / delivery

Direct-to-consumer only; no wholesale; may sell from residence, farmers markets, online (CO only)

If you rent a commissary kitchen

Retail food licenses are local. Colorado cottage foods cannot be sold in a retail food establishment as an approved source. A commissary is a retail food establishment licensed by the local public health agency.
