HOW THIS PLACE WORKS

Georgia no longer sells a state cottage-food license. HB 398 (effective July 1, 2025) removed the Georgia Department of Agriculture cottage-food license and fee. What may still apply is city or county occupational tax and zoning. This packet keeps the GDA program page so you can read the current state rules.

Where to file

State

Georgia registration: No. Routine kitchen inspection: Upon-complaint. As of July 1, 2025 (HB 398), Georgia allows wholesale, online, retail store, restaurant, and mail-order sales; third-party sellers must display cottage food products separately and label the section as products from residential kitchens exempt from state inspection.

Zoning / home occupation

Conditional. Georgia state law (O.C.G.A. §26-2-470 et seq.) does not preempt local zoning. Cottage food operators must check with Appling County and the City of Baxley to determine if a home-based business is allowed in their zoning district and whether a home occupation permit is required. GDA registration form previously required operators to confirm local compliance; under HB 398 (no state license required) local zoning still applies.

Health

Upon-complaint. Complaint-based only under HB 398 (eff. July 2025). GDA may enter premises upon receipt of a consumer complaint, foodborne illness outbreak, or public health emergency.

Business license

Pickup / delivery

Under HB 398 (eff. July 2025): direct-to-consumer sales, online sales, sales to retail stores, restaurants, and interstate sales are all permitted. No wholesale distribution through intermediaries. Events and farmers markets permitted.

If you rent a commissary kitchen

A commissary is a food-service permit, not occupational tax. Georgia no longer sells a GDA cottage license (HB 398). A rented kitchen is still a food-service establishment permitted by the county health department or the Department of Public Health. Occupational tax is not that permit.
