HOW THIS PLACE WORKS

Georgia no longer sells a state cottage-food license. HB 398 (effective July 1, 2025) removed the Georgia Department of Agriculture cottage-food license and fee. What may still apply is city or county occupational tax and zoning. This packet keeps the GDA program page so you can read the current state rules.

Where to file

State

Georgia registration: No. Routine kitchen inspection: Upon-complaint. As of July 1, 2025 (HB 398), Georgia allows wholesale, online, retail store, restaurant, and mail-order sales; third-party sellers must display cottage food products separately and label the section as products from residential kitchens exempt from state inspection.

Zoning / home occupation

Varies. Glynn County and the City of Brunswick (Golden Isles area) may have home occupation ordinances. No Glynn County-specific cottage food ordinance identified. Glynn County Community Development should be consulted.

Health

Upon-complaint. Complaint-based only under HB 398.

Business license

Varies

Pickup / delivery

All channels now open under Georgia HB 398: direct, indirect, retail, wholesale, online, restaurant sales, and interstate.

If you rent a commissary kitchen

A commissary is a food-service permit, not occupational tax. Georgia no longer sells a GDA cottage license (HB 398). A rented kitchen is still a food-service establishment permitted by the county health department or the Department of Public Health. Occupational tax is not that permit.
