HOW THIS PLACE WORKS

Georgia no longer sells a state cottage-food license. HB 398 (effective July 1, 2025) removed the Georgia Department of Agriculture cottage-food license and fee. What may still apply is city or county occupational tax and zoning. This packet keeps the GDA program page so you can read the current state rules.

Where to file

State

Georgia registration: No. Routine kitchen inspection: Upon-complaint. As of July 1, 2025 (HB 398), Georgia allows wholesale, online, retail store, restaurant, and mail-order sales; third-party sellers must display cottage food products separately and label the section as products from residential kitchens exempt from state inspection.

Zoning / home occupation

Varies. No county-specific cottage food overlay found. Lumpkin County may require a business license for commercial activity. Home occupation rules vary by zoning district under Lumpkin County's zoning ordinance. Dahlonega is an active tourism and wine country hub with active farmers markets; event-specific or vendor permits may be required by Dahlonega or Lumpkin County for market sales.

Health

Upon-complaint. GDA may inspect upon consumer complaint or reported foodborne illness.

Business license

Yes

Pickup / delivery

Under HB 398, sales permitted via wholesale, retail, online, and direct. Delivery allowed. No geographic sales restriction within Georgia; interstate sales now permitted.

If you rent a commissary kitchen

A commissary is a food-service permit, not occupational tax. Georgia no longer sells a GDA cottage license (HB 398). A rented kitchen is still a food-service establishment permitted by the county health department or the Department of Public Health. Occupational tax is not that permit.
