Where to file

State

Idaho registration: No. Routine kitchen inspection: No. Idaho prohibits wholesale, restaurant, and retail store sales; only direct-to-consumer in-person sales at home, farmers markets, events, online (pickup/delivery), and roadside stands are allowed.

Zoning / home occupation

Conditional. Blaine County includes Sun Valley resort area and has more developed zoning regulations. Blaine County Zoning Ordinance governs home occupations in unincorporated areas. Home-based businesses are generally allowed as accessory uses in residential zones but typically require a home occupation permit, must remain secondary to residential use, have no exterior signage or commercial traffic beyond residential norms. If you rent a commissary kitchen

Health districts permit food establishments. Idaho cottage food is a home exemption. A commissary is a food establishment permitted by the local public health district.
