Where to file

State

Idaho registration: No. Routine kitchen inspection: No. Idaho prohibits wholesale, restaurant, and retail store sales; only direct-to-consumer in-person sales at home, farmers markets, events, online (pickup/delivery), and roadside stands are allowed.

Conditional. Canyon County and City of Caldwell may require home occupation permits under local zoning. Check with Canyon County Planning & Development or City of Caldwell Planning.

Direct-to-consumer only: home, farmers markets, events. No wholesale, no retail, no internet/mail order to out-of-state consumers.

If you rent a commissary kitchen

Health districts permit food establishments. Idaho cottage food is a home exemption. A commissary is a food establishment permitted by the local public health district.
