Where to file

State

Idaho registration: No. Routine kitchen inspection: No. Idaho prohibits wholesale, restaurant, and retail store sales; only direct-to-consumer in-person sales at home, farmers markets, events, online (pickup/delivery), and roadside stands are allowed.

Zoning / home occupation

Conditional. Elmore County includes Mountain Home AFB and has a more developed planning department than some Idaho rural counties. Home occupations in unincorporated areas typically require a home occupation permit; business must be secondary to residential use, operated by a resident, no exterior commercial signage, limited customer traffic. Contact Elmore County Planning & Zoning at (208) 587-2025 for specific permit requirements.

Health

No. No routine inspection. Central District Health (serving Elmore County) may investigate upon complaint.

Business license

Pickup / delivery

Idaho cottage food allows direct sales to consumers; home pickup is permitted. Delivery to consumers is permitted. No mail order or internet sales under state law.

If you rent a commissary kitchen

Health districts permit food establishments. Idaho cottage food is a home exemption. A commissary is a food establishment permitted by the local public health district.
