Where to file

State

Idaho registration: No. Routine kitchen inspection: No. Idaho prohibits wholesale, restaurant, and retail store sales; only direct-to-consumer in-person sales at home, farmers markets, events, online (pickup/delivery), and roadside stands are allowed.

Zoning / home occupation

Conditional. Nez Perce County is a larger county with the city of Lewiston (Idaho's only seaport). The county has an active planning department. Home occupations in unincorporated areas typically require a home occupation permit; business must be secondary to residential use, operated by a resident, no exterior commercial signage, limited customer traffic. Properties within Lewiston city limits are subject to Lewiston city zoning. Contact Nez Perce County Planning at (208) 799-3090 for specific requirements.

No. No routine inspection. North Central District Health (serving Nez Perce County) may investigate upon complaint.

Idaho cottage food allows direct sales to consumers; home pickup is permitted. Delivery to consumers is permitted. No mail order or internet sales under state law.

If you rent a commissary kitchen

Health districts permit food establishments. Idaho cottage food is a home exemption. A commissary is a food establishment permitted by the local public health district.
