Where to file

State

Idaho registration: No. Routine kitchen inspection: No. Idaho prohibits wholesale, restaurant, and retail store sales; only direct-to-consumer in-person sales at home, farmers markets, events, online (pickup/delivery), and roadside stands are allowed.

Zoning / home occupation

Conditional. Oneida County is a small rural southeastern Idaho county near the Utah border. Home-based businesses are generally allowed as accessory residential uses. Contact Oneida County at (208) 766-4116 for any applicable zoning requirements.

No. No routine inspection. Southeastern Idaho Public Health (serving Oneida County) may investigate upon complaint.

Idaho cottage food allows direct sales to consumers; home pickup is permitted. Delivery to consumers is permitted. No mail order or internet sales under state law.

If you rent a commissary kitchen

Health districts permit food establishments. Idaho cottage food is a home exemption. A commissary is a food establishment permitted by the local public health district.
