Where to file

State

Idaho registration: No. Routine kitchen inspection: No. Idaho prohibits wholesale, restaurant, and retail store sales; only direct-to-consumer in-person sales at home, farmers markets, events, online (pickup/delivery), and roadside stands are allowed.

Zoning / home occupation

Conditional. Owyhee County is a vast, sparsely populated southwestern Idaho county bordering Nevada and Oregon. Very rural with minimal zoning enforcement expected. Home-based businesses are generally allowed as accessory residential uses. Contact Owyhee County at (208) 495-2421 for any applicable zoning requirements.

Health

No. No routine inspection. Southwest District Health (serving Owyhee County) may investigate upon complaint.

Business license

Varies

Pickup / delivery

Idaho cottage food allows direct sales to consumers; home pickup is permitted. Delivery to consumers is permitted. No mail order or internet sales under state law.

If you rent a commissary kitchen

Health districts permit food establishments. Idaho cottage food is a home exemption. A commissary is a food establishment permitted by the local public health district.
