Where to file

State

Idaho registration: No. Routine kitchen inspection: No. Idaho prohibits wholesale, restaurant, and retail store sales; only direct-to-consumer in-person sales at home, farmers markets, events, online (pickup/delivery), and roadside stands are allowed.

Zoning / home occupation

Conditional. Teton County, Idaho is a growing resort/tourism county adjacent to the Tetons and Grand Teton National Park on the Wyoming border. The county has more active land use regulations than many rural Idaho counties due to development pressure. Home occupations in unincorporated areas typically require a home occupation permit and must remain secondary to residential use. Idaho cottage food allows direct sales to consumers; home pickup is permitted. Delivery to consumers is permitted. No mail order or internet sales under state law.

If you rent a commissary kitchen

Health districts permit food establishments. Idaho cottage food is a home exemption. A commissary is a food establishment permitted by the local public health district.
