Where to file

State

Idaho registration: No. Routine kitchen inspection: No. Idaho prohibits wholesale, restaurant, and retail store sales; only direct-to-consumer in-person sales at home, farmers markets, events, online (pickup/delivery), and roadside stands are allowed.

Zoning / home occupation

Conditional. Valley County is a mountainous central Idaho county that includes McCall, a popular resort and recreation area. More active planning than many rural Idaho counties. Home occupations in unincorporated areas typically require a home occupation permit and must remain secondary to residential use. Contact Valley County Planning at (208) 382-7115 for specific permit requirements.

Health

No. No routine inspection. Central District Health (serving Valley County) may investigate upon complaint.

Business license

Pickup / delivery

Idaho cottage food allows direct sales to consumers; home pickup is permitted. Delivery to consumers is permitted. No mail order or internet sales under state law.

If you rent a commissary kitchen

Health districts permit food establishments. Idaho cottage food is a home exemption. A commissary is a food establishment permitted by the local public health district.
