## Where to file

### State

Indiana registration: No. Routine kitchen inspection: Upon-complaint. Sales to restaurants, retail stores, and wholesale are prohibited; producers may sell at events, farmers markets, home, online, and roadside stands only.

### Zoning / home occupation

Varies. Kosciusko County and the City of Warsaw (orthopedic device industry capital) may have home occupation ordinances. No specific Kosciusko County cottage food ordinance identified.

### Health

Upon-complaint. No routine inspection. Indiana law preempts local licensing/inspection. Local health dept may investigate upon complaint.

### Business license

Varies

### Pickup / delivery

Direct sales from home, online within Indiana, at events and farmers markets permitted.

### If you rent a commissary kitchen

**Local health departments license retail food.** Indiana home-based vendor rules do not replace a retail food establishment permit. A commissary is licensed by the local health department.
