Where to file

State

Indiana registration: No. Routine kitchen inspection: Upon-complaint. Sales to restaurants, retail stores, and wholesale are prohibited; producers may sell at events, farmers markets, home, online, and roadside stands only.

Zoning / home occupation

Varies. Indiana preempts local licensing and inspection requirements for home-based vendors. LaPorte County unincorporated areas or city of La Porte may have general home occupation zoning permits. Note: county_seat in input is blank but is La Porte. Contact LaPorte County Planning or city zoning for zoning-specific requirements.

Health

Upon-complaint. Indiana preempts local licensing/inspection requirements. Inspection only upon complaint or illness investigation.

Business license

Varies

Pickup / delivery

Indiana allows direct sales only: from home, online, farmers markets, events. No wholesale to restaurants or retail stores. Interstate sales prohibited.

If you rent a commissary kitchen

Local health departments license retail food. Indiana home-based vendor rules do not replace a retail food establishment permit. A commissary is licensed by the local health department.
