Where to file

State

Indiana registration: No. Routine kitchen inspection: Upon-complaint. Sales to restaurants, retail stores, and wholesale are prohibited; producers may sell at events, farmers markets, home, online, and roadside stands only.

Varies. No county govt URL provided. Morgan County unincorporated areas would follow county zoning ordinance for home occupation rules. City of Martinsville has its own zoning. No specific cottage food overlay identified.

If you rent a commissary kitchen

Local health departments license retail food. Indiana home-based vendor rules do not replace a retail food establishment permit. A commissary is licensed by the local health department.
