Where to file

State

Indiana registration: No. Routine kitchen inspection: Upon-complaint. Sales to restaurants, retail stores, and wholesale are prohibited; producers may sell at events, farmers markets, home, online, and roadside stands only.

Health

Upon-complaint. Complaint-based; local health department cannot require routine inspection under HEA 1149

Business license

Varies

Pickup / delivery

Direct sales only; may sell from home, online, farmers markets, events. No wholesale, catering, or interstate sales.

If you rent a commissary kitchen

Local health departments license retail food. Indiana home-based vendor rules do not replace a retail food establishment permit. A commissary is licensed by the local health department.
