Where to file

State

Indiana registration: No. Routine kitchen inspection: Upon-complaint. Sales to restaurants, retail stores, and wholesale are prohibited; producers may sell at events, farmers markets, home, online, and roadside stands only.

Zoning / home occupation

Varies. State HBV law preempts local food licensing and inspection requirements. However, local zoning ordinances for home occupations may apply. Contact White County Plan Commission (Monticello) to verify any home occupation permit requirements for a home-based food business.

Health

Upon-complaint. Indiana Department of Health may inspect upon complaint or food safety concern; local health department enforces.

Business license

Varies

Pickup / delivery

Direct-to-consumer only. Sales allowed in person, by phone, online, or via third-party carrier within Indiana. No interstate shipping. No wholesale or retail resale.

If you rent a commissary kitchen

Local health departments license retail food. Indiana home-based vendor rules do not replace a retail food establishment permit. A commissary is licensed by the local health department.
