Where to file

State

Iowa registration: No. Routine kitchen inspection: No. Cottage food direct-to-consumer sales only; however, a separate Home Food Processing Establishment (HFPE) license allows indirect retail and wholesale sales of almost any food including perishables.

Zoning / home occupation

No. Iowa §137F.20(1) preempts local restrictions. Council Bluffs may have business license requirements unrelated to cottage food; operators should verify.

No. No inspection authority for Iowa cottage food operations.

Pickup / delivery

Direct sales only to end consumers. Home, farmers markets, events. No indirect retail/wholesale under cottage food exemption.

If you rent a commissary kitchen

DIA licenses food establishments. Iowa cottage food is an exemption. A commissary or food establishment is licensed by the Department of Inspections, Appeals, and Licensing (or the local board of health where they inspect).
