Where to file

State

Iowa registration: No. Routine kitchen inspection: No. Cottage food direct-to-consumer sales only; however, a separate Home Food Processing Establishment (HFPE) license allows indirect retail and wholesale sales of almost any food including perishables.

Zoning / home occupation

No. Iowa §137F.20(1) preempts local restrictions on cottage food operations. Story County (home to Ames and Iowa State University) follows state preemption.

Health

No. No inspection authority for Iowa cottage food operations.

Business license

Pickup / delivery

Direct sales only to end consumers from home, farmers markets, events. No indirect retail/wholesale under cottage food exemption. Separate Home Food Processing Establishment pathway available for broader distribution.

If you rent a commissary kitchen

DIA licenses food establishments. Iowa cottage food is an exemption. A commissary or food establishment is licensed by the Department of Inspections, Appeals, and Licensing (or the local board of health where they inspect).
