This is what it takes to sell from a home kitchen in Franklin County. Confirm each step with Planning, Health, and the license office before you sell.

Franklin County, Kansas. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. No state-level food permit required for non-TCS cottage foods. Local zoning ordinances for home occupations may require a permit. Contact Franklin County zoning or planning office (Ottawa) to verify requirements.

Health

Upon-complaint. Kansas Department of Agriculture may investigate complaints; no routine home kitchen inspection for exempt cottage food operations.

Business license

Varies

Pickup / delivery

Direct-to-consumer only. Sales allowed at home, farmers markets, events, roadside stands, online with delivery within Kansas. No wholesale or retail resale. Out-of-state shipping allowed with additional requirements.

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
