Hamilton County, Kansas. File every Yes. Confirm every Check or Ask. Stay under the sales cap.

Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. No state-level food permit required for non-TCS cottage foods. Local zoning ordinances for home occupations may require a permit. Contact Hamilton County zoning or planning office (Syracuse) to verify requirements.

Health

Upon-complaint. Kansas Department of Agriculture may investigate complaints; no routine home kitchen inspection for exempt cottage food operations.

Business license

Varies

Pickup / delivery

Direct-to-consumer only. Sales allowed at home, farmers markets, events, roadside stands, online with delivery within Kansas. No wholesale or retail resale. Out-of-state shipping allowed with additional requirements.

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
