Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. Kearny County is a small rural western Kansas county. Unincorporated areas governed by county zoning. Contact Kearny County Clerk or Planning office for home occupation permit requirements. Home occupation likely permitted as accessory use in agricultural zones.

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
