Where to file

State

Kansas registration: No. Routine kitchen inspection: Upon-complaint. Indirect sales to restaurants, retail stores, or wholesale are not allowed under the exemption; producers needing wholesale or retail channels must obtain a KDA food processing license.

Zoning / home occupation

Varies. Kingman County Planning & Zoning administers unincorporated county zoning. Home occupation permit likely required in residential zoning districts. Contact Kingman County for specific requirements. City of Kingman has separate jurisdiction within city limits.

Business license

Pickup / delivery

Direct delivery to consumer permitted in-state

If you rent a commissary kitchen

KDA licenses food establishments. Kansas cottage food is an exemption from a food-establishment license. Selling from a commissary typically requires a KDA food establishment or food processing license.
